### Pursuant to the EU Regulation, the data subject has the rights to:

- Access to personal data (Article 15)
  (Access shall not adversely affect the rights of other natural persons)
- Rectification and completion of personal data (Article 16)
- **Erasure** of personal data right to be forgotten (Article 17)
  - published personal data
  - unnecessary personal data
  - unlawfully processed personal data
  - personal data for direct marketing purposes
  - personal data after withdrawal of consent, where there is no other legal ground for the processing
  - This right does not apply to data processed:
    - in the exercise of official authority vested in the controller
    - for archiving purposes, scientific/statistical purposes and historical research; for exercising the right of freedom of expression and information and for the establishment and exercise of legal claims
  - Restriction of processing of personal data (Article 18)
    - during the correction of incorrect data
    - pending the verification of whether the data were processed in the exercise of official authority or whether the legitimate grounds of the controller override those of the data subject
    - if the data subject opposes the erasure of the data and requests the restriction of processing instead
    - if the controller no longer needs the data and the data subject needs them for the exercise of legal claims
  - Portability of personal data processed by automated means (Article 20)
    - when the processing of data is based either on the consent of the data subject or on a contract between the controller and the data subject
    - this right shall not apply to data which are processed in the exercise of official authority vested in the controller
  - Object to the processing of personal data (Article 21)
    - when processed in the public interest
    - carried out in the exercise of official authority vested in the controller
    - in the legitimate interests of the controller if the controller continues to process them, he shall provide justification
    - in processing for direct marketing purposes the controller forthwith suspends processing

The controller may restrict the scope of the rights provided to data subjects within the meaning of Article 23 of the EU Regulation if such a restriction is provided to safeguard, in particular, the rights of the data subject or other persons and the enforcement of civil law claims.

**The data subject has the right** to lodge a complaint with the Office for Personal Data Protection, Hraničná 12, Bratislava as provided in Article 13 (2) (d) of the EU Regulation.

The data subject declares himself/herself to be acquainted with this information.
